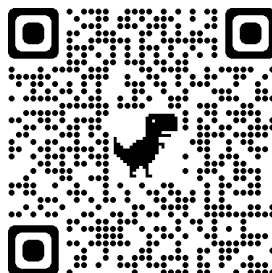

Player Entry fee covers entry for one Singles and one Doubles, the Sunday Night Dinner dance, courtside refreshments and balls for all matches.

Entries: **Deadline to register and submit payment is Friday, August 20, 2021, for both online or paper registration.**

Deadline for Tri-City Clubs to submit approved paper entry forms and all fees collected is Monday, August 23, 2021. Clubs are requested to email approved paper registration entries to motorcitytennisclub1929@gmail.com and make payment through PayPal.

Limits for Entries: Players are limited to two (2) events; one singles and one doubles or two doubles. One doubles must be mixed.

Minimum No. Players: All events must have a minimum of four (4) participants or you will be moved to the next lowest event.

Indoor Courts: There will be a \$5.00 fee per person, per day if indoor court time is needed due to inclement weather

Eligibility: Players must be current financial members of one of the Tri-City Clubs to participate in the tournament: Forest City Tennis Club, Motor City Tennis Club or Chicago Prairie Tennis Club. Membership will be verified. Please contact your local Tri-City President to confirm your membership status.

Tournament Format: All matches, unless otherwise stated, will be the best two (2) out of three (3) sets, scored under the No-Ad system through the quarters. A twelve (12) point tiebreaker will be played when any set reaches six (6) all.

There will be a 30-minute default time on the first day of play and a 15-minute default time thereafter. Players who have not reported ready for play/checked in after the match is called will be defaulted.

Draw: Draw will be held on Saturday, August 28, 2021, at 11:00AM. Each Tri-City Club President should email seeding and ranking information to motorcitytennisclub1929@gmail.com no later than Friday, August 27, 2021.

The final draw will be posted online by Wednesday, September 1, 2021.
